### COACHES should bring:

Red USA Boxing coach's passbook with current registration AND Safe Sport/background check  
\*\*\* passbook must show **current coach registration status**

### BOXERS should bring:

USA Boxing passbook \*\*\* you **cannot box** without USA Boxing passbook  
\*\*\* proof of current athlete physical, completed within last 12 months;  
Tournament doctors will **not** be providing annual physicals at the event  
\*\*\* Boxers must register by March 1<sup>st</sup>, 2020 (online or by mail) to be entered into tournament draw  
Proof of age (e.g. birth certificate, passport)  
USA Boxing approved headgear  
Mouth-guard (\*\*\*) **no red** allowed on mouth-guard)  
Trunks with a contrasting color on waistband  
Appropriate footwear  
Boxing jersey  
(male) Groin protection; *must* be clean shaven at weigh-in  
(female) groin and/or breast protection *optional*

### ALSO:

- \* Female boxers must provide a Declaration of non-Pregnancy and Breast Implant release if necessary
- \* Boxers with braces must provide a signed Release to compete with braces
- \* a \$5 registration fee will be due at check-in

*A boxer with 6+ bouts may declare themselves open for the opportunity to compete for a place on the WI team, at the approval and discretion of their coach and WI GG officials.*

**\*\* Male and Female elite open** champions from each weight class will advance to the National Golden Gloves tournament- May 3-9 in Tulsa OK (travel 2<sup>nd</sup> and 10<sup>th</sup>)

**\*\* Unopposed** Male and Female eligible elite boxers may advance with the National team at discretion of WI GG officials

**\*\* Novice elite** champions with 6+ bouts may be eligible to advance with the National Team in unclaimed weight classes, at the discretion of WI GG officials
